## **Voter Identification**

To vote in the election, a person may present proof of identity and residence before a ballot is issued. You have 2 options for ID:

- One piece of identification issued by the Government of Canada, the Government of Saskatchewan, a municipality, or a government agency that contains a photograph of the voter and his or her name and address. A valid driver's license or Saskatchewan non-drivers photo-ID, or other Government issued ID that has your name, photo, and current address. If you use your Driver's License for ID, you do not need a second piece of ID.
- Two pieces of pieces of information, each of which establishes the voter's name and at least one of which establishes the voter's address. Any two listed below is acceptable:
